CORONAVIRUS **SMALL BUSINESS SCHEME**

A one-off grant of £10,000 is available if clubs receive Small Business Bonus Scheme relief and Rural Relief. This has now been extended to cover Discretionary Sports Relief. Bowling Clubs can apply for these Grants via the clubs Local Authority here

COALFIELDS REGENERATION **TRUST EMERGENCY RESPONSE GRANT**

Organisations that are providing essential services within their communities can apply for a grant of between £100.00 - £1,000.00 with a maximum of £1000 per village / town.
